All dues are payable at registration OR 50% plus a \$25.00 admin fee at registration and the remaining 50% prior to Jan. 15, 2021. Third year discount has been removed. All dues include a \$25.00 capital levy fee as per the BCC Constitution & By-Laws. Capital Levy amount may be changed by the Board prior to registration.
